The fees below are a guide only and are current as at 01 September 2026

You can choose to pay for your accommodation by three separate ways. A Refundable Accommodation Deposit (RAD), a Daily Accommodation Payment (DAP) or a combination of a RAD/DAP. The DAP is calculated using the interest rate set by the Australian Government. The figures in this document were calculated using the interest rate of 8.43%.

Fully or Partially Supported Resident: If your assets are below \$214,884.00 and you meet the annual income tests for Residential Care via Centrelink, you may be eligible for a Partial or Fully Supported Placement. Please discuss with the Admissions Manager for further information.

Daily Fees

Basic Daily Care Fee: This fee is a Government regulated fee and is adjusted bi-annually with the Commonwealth Aged Care Pension. As at 20 March 2026 this fee is \$66.80 per day. It will be indexed again in September 2026.

Non Clinical Care Contribution: The government requires those who they assess eligible to pay a Non Clinical Care Contribution (NCCC) alongside the Basic Daily Fee. The Department of Human Services assesses income and assets to determine this fee, which will be noted in the resident's Centrelink / DVA Assessment letter. The Maximum NCCC is \$107.32 per day, and \$137,917.01 over a lifetime (both indexed).

Hotelling Contribution: The government requires those who they assess as eligible to pay a Hotelling Contribution alongside the Basic Daily Fee, to top up the Basic Daily Fee to cover the cost of daily living services. The Department of Human Services assesses income and assets to determine this fee, which will be noted in the resident's Centrelink / DVA Assessment letter. The maximum daily Hotelling Contribution is \$22.15 per day (indexed).

Higher Everyday Living Fee: Trinity Manor Balwyn offers Higher Everyday Living services. There are a number of package levels which may be selected. See flyer for more details.

Respite Fees: The Respite Fee is the same as the Basic Daily Care fee. Higher Everyday Living packages are also available.
